

## The Hall of Fame Criteria

A nomination for induction into the Amity Regional High School Alumni Athletic Hall of Fame may be submitted by any Alumni or friend of Amity Regional High School. A nominee must meet the criteria in one of the following categories:

- **Athletic and Personal Achievement:** A former Amity Athlete who performed with excellence and lettered in a Varsity sport. Must be a graduate and out of school for at least ten (10) years. Nominees must be, or have been a credit to his/her Family, Country and Amity. The inductee may be either living or deceased.
- **Coaches:** A Nominee must have been a coach within the Amity Regional High School system for minimum of ten (10) years and who has distinguished himself by demonstrating exceptional leadership, character and athletic achievement during his/her stay at Amity. The inductee may be either living or deceased.
- **Special Award:** A person who has been a loyal and devoted supporter of Amity Athletic for a minimum of ten (10) years. The inductee may be either living or deceased.

#### By-Laws of Amity Alumni Athletic Hall of Fame

**Article I** – There shall be an established Amity Alumni Athletics Hall of Fame Committee, which shall exist within the structure of the Amity Athletic Booster Club, and which shall be comprised of a maximum of 15 members, two of whom shall serve as co-chairpersons. Inductees will automatically become permanent members of the Committee following their induction year. Said Committee shall be responsible for the requisition and processing of nominations of candidates to said Alumni Athletic Hall of Fame, and said Committee shall elect, by a highest point total, inductees from said candidates. Players, coaches and devoted supporters, living or deceased, shall be eligible for induction subject to the criteria stated in Article II. **Article II** – To be eligible for nomination, a student-athlete shall have graduated from Amity Regional High School at least 10 years prior to his/her induction into said Alumni Athletic Hall of Fame. Coaches, after coaching ten years in the Amity Regional High School system, can also be nominated. Any devoted supporter of the athletic program for a period of over 10 years can also be nominated. Any person may submit a nomination on the official nomination form. Said nominations shall be made in writing, signed and supported by facts relative to the performance of said nominee at Amity Regional High School. In addition to having achieved excellence in his/her sport, a student-athlete, coach or devoted supporter shall have exhibited the highest ideals and standards of sports participation including good sportsmanship, integrity, honesty, self-sacrifice, and determination. **Article III** – Inductees shall receive a plaque at an annual event to be held in June of each year. A duplicate plaque will go on permanent display in the school's Wall of Fame. **Article IV** – The Committee shall have the authority to review and update the By-Laws yearly, and the adoption of said By-Laws shall be a majority vote of the Committee Members.
